ONLINE SERVICES APPLICATION FORM

We are pleased to offer you the facility to use 'SystmOne Online' which provides internet services for all patients:

- View, book or cancel doctor or nurse appointments
- View a list of your current medication and send repeat prescription requests
- View your prospective consultations, (not previous history)
- View letters received from other healthcare organisations
- View test results
- View summary care records, including your sensitivities and allergies
- View your past detailed coded medical record
- Access to the detail coded record of your children up to the age of 11

Appointments

It is preferable that in the first instance for a request for a GP appointment or advice, you complete an eConsult. You will then be contacted by the surgery with the most suitable appointment or advice. It is possible to book a doctor appointment online when prompted by a text link from your GP. Some types of nurse appointments are bookable online if you have received an invitation.

Please contact reception for other appointments.

If you feel that you need longer with your doctor, please let us know.

If you subsequently decide that you no longer require the appointment, please ensure that it is cancelled to enable the time to be offered to someone else. Please cancel by either the online facility or be telephoning reception.

Repeat Prescriptions

To ensure patient safety and good medical practice we require a full 3 working day turnaround of your repeat prescription requests. Please note that any repeat medication requests will not be processed for authorisation earlier than 10 days before the due date. If there are exceptional circumstances such as travel then you **must** inform us.

Ways to request repeat medication

- 1. The preferred method is for you to register for online access, this will allow you to request repeat prescriptions, via your preferred choice of App.
- 2. Email us on sxicb-wsx.medications.lmp@nhs.net
- 3. By post
- 4. In person

For patient safety we are unable to take telephone requests for medication, unless by **prior** agreement with your named doctor.

Registering

If you would like to register for our online services, please complete **Part 1** of this 'Online Services Application Form' and if you would like to view your coded record please also complete **Part 2** of the 'Consent Form' available on our website www.loxwoodmedicalpractice.co.uk or from reception, or complete the 'sign up' request form via SystmOnline. Please return completed forms to the practice in person, with photographic proof of identification e.g. passport or driving licence. To ensure confidentiality we are only able to accept registrations in person - i.e. you cannot give your details to anyone else to register for you.

Our reception staff will register you, provide you with unique login details and a secure password.

- Your Medical Record is important and you should keep all information safe and secure, just like your Bank Account details.
- No one should force you to share your GP record. You have the right to say NO. If this happens, tell us as soon as possible.
- Take extra care if using a shared computer, keep your login details safe and remember to log out. If you think someone has seen your password, change it as soon as possible or call our reception.

If you would like to have secure access to view your coded medical record, we need to make sure that you understand what this involves. The following form will take you through the things you need to think about. By signing this form you will be giving us your permission to go ahead with setting you up with access to this service. If you decide not to join or wish to withdraw, this will not affect your healthcare treatment in any way.

Your request can take up to 28 days to process. You will be informed if access is not granted.

What are Online Services?

SystmOnline will help empower you, to take greater control of your own health and wellbeing. Our aim is to offer you more choice and control as well as convenience. Patients who are informed and involved in their own care, have better health outcomes.

- 1. Once registered and logged on for the first time, you may find it helpful to view 'Using SystmOnline—A Guide for Patients' found by clicking on the 'Help' link within the main menu. Change your password to something more memorable, immediately.
- 2. Protect your GP online records. Just like online banking keep your username and password safe and secure. Take extra care if using a shared computer and always 'log out' when you have completed your transaction. Do not share your personal information with others. No one should force you to show them your login details. Contact us if you are worried or need further advice with any aspect of your online account.
- 3. Please use this online service responsibly; access can be withdrawn at any time, at the discretion of your GP.
- 4. Remember, you may see information in your coded medical record that you were unaware of or have forgotten about, that could cause you some anxiety or distress.
- 5. All pathology results will be visible. We will notify you of any new pathology result that needs further action, however you may see results that need further action <u>before</u> we have been able to contact you.
- 6. On rare occasions information on your record may be incorrect. Please inform us as soon as possible. If you see information about anyone else, log out immediately and let us know.

SystmOnline is also available as an app and can be used on both Apple and Android devices.

We recognise that computers, tablets and smart phones are not a substitute for visiting or telephoning us or other health services, and that not all patients have access to computers or online services.
